Application for deferment

If you have been admitted to a programme or a course but circumstances have occurred that make it not possible for you to commence your studies at the given start date, you can apply for deferment. Deferment of studies may be granted if there are special grounds.

Special grounds for deferment can be social, medical or other circumstances, e.g. care of children, military service or civil defence service, missions for the student union or postponed leave according to the law about employers right to leave for education (lagen (1974:981) om arbetstagares rätt till ledighet för utbildning).

Deferment from your studies may not exceed 18 months unless there are exceptional reasons for prolongation of the deferment requested.

The reasons you claim must be motivated and proof of this must be enclosed with this application (e.g. doctor's report).

Application for deferment at Mid Sweden University

Mid Sweden University will assess applications for deferment individually. For your application to be processed you have to be admitted to an education.

If you are granted deferment, a decision notice will be sent to you by e-mail. Then you have to apply for the education again and submit/upload a copy of the decision notice along with your application. There will be more information in the decision notice.
