HIGHER EDUCATION (HE) between Programme Countries (KA103)

1. Travel - Contribution to the travel costs

Staff mobility and HE students sent by HEIs from outermost Programme Countries and regions and Overseas Countries and Territories

Travel distances	Amount
Between 10 and 99 KM:	20 EUR per participant
Between 100 and 499 KM:	180 EUR per participant
Between 500 and 1999 KM:	275 EUR per participant
Between 2000 and 2999 KM:	360 EUR per participant
Between 3000 and 3999 KM:	530 EUR per participant
Between 4000 and 7999 KM:	820 EUR per participant
8000 KM or more:	1500 EUR per participant

Nota bene: the "travel distance" represents the distance between the place of origin and the venue, whereas the "amount" covers the contribution to the travel both to and from the venue.

- **Student mobility for traineeships:** additional top-up of **195 EUR/month**
- **Students from disadvantaged backgrounds (other than those with special needs) for mobility for studies :** additional top-up of **200 EUR/month**. Students from disadvantaged backgrounds who take part in traineeships are entitled to receive the top-up for students from disadvantaged backgrounds instead of the top-ups for traineeships, in case the top-up for traineeships is lower.

3. Organisational support

Up to the 100th participant: 350 EUR per participant

+ beyond the 100th participant: 200 EUR per additional participant.
